We are looking for **research proposals** aiming to solve practical problems of urban drainage systems using the **17 facilities** provided in the project.

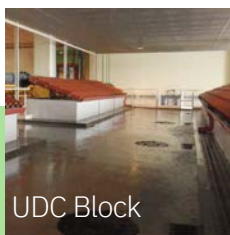

We have two different modalities to
access our network

In-Person Access

- 1 team member in the facility for the whole #TA duration
- 5 short visits
- #TA access for 15 to 60 working days

Partially-remote access

- Mid- and long-term performance tests
- 2 visits (start and end of tests)
- #TA access for 10 to 20 working days

FREQUENTLY ASKED QUESTIONS

What does 'free of charge' mean exactly?

According to the H2020 regulations, Co-UDlabs will be able to cover all associated costs for accommodation, travel, and living expenses (such as meals) of the user-group members who will travel to a facility

I am not based in Europe. Can I apply to the Transnational Access call?

Yes! However, participation is limited by INFRAIA H2020 rules. Access of groups in which a majority of members are from non-European and non-associate countries is limited to 20% of total granted access days. We recommend you take a look at the [official list of H2020 Associated Countries](#)

I may have an idea, but I wish I had feedback or support. Is there a way?

Of course! We have planned several training activities around the #TA call: on November 23 and 25, 2021, we will hold a Hackathon event, in which early proposals or just fledgling ideas can be debated, improved or re-thought as participants will be tasked with solving UD challenges with innovative and interdisciplinary approaches. You can access the Hackathon Guidelines to learn more about the event. Participating in the Hackathon is not mandatory for the #TA, but it may be a very fruitful experience!

Can I know more about available budget or working requirements at a specific facility?

Absolutely: we believe it is essential that you are aware at all times about whether your idea is feasible in the facility of your choice. Each institution has budget allocated specifically for transnational access to their installations. We strongly recommend that you contact the team in charge of the facility you are interested in, so that they can provide you with updated information, guidance, and recommendations to tailor your proposal to the requirements of their facility. Can my team members be based all in the same institution?


Yes, whenever a proposal meets the criteria it will be evaluated. However, Co-UDlabs also aims at improving multi-disciplinary collaboration and cross-sector knowledge. The ability of a team to include diverse backgrounds and expertise will be positively assessed
